- 2. A photo is attached to show current location and current condition (attached as Exhibit A).
- 3. Each bidder will briefly specify the method of purchase and transportation of said kiosk and book return.
- 4. Each bidder must guarantee that it has the capacity to safely handle, removal and transportation the items described in specification 1.
- 5. Each bidder must clearly state the date for removal of items described in specification 1.
- 6. Each bidder must agree to provide a contact telephone number to the County Librarian and the Auditor's Office.
- 7. Each bidder agrees, at its sole expense, to obtain and keep in force and effect during the term of the contract, a general liability insurance policy to protect Wilson County against any liability for personal injury or death, or property damage to the County, its employees, officials, adjoining landowners and the public, based on the bidder's carrying out of this contract..
- 8. Each bidder must agree to comply with the federal, state and local laws and regulations pertaining to the subject of this bid. It is the responsibility of the successful bidder to educate itself to comply with these laws, and not the county's obligation to educate it.
- 9. One *bidder* will be selected by Wilson County: the one with the highest and best bid.

- 15. The bid, when properly accepted by Wilson County, shall constitute a contract binding on both parties with the terms herein making up the contract terms. No oral statement of any person shall modify any part of the Bid Specification or resulting contract.
- 16. The successful bidder must comply with Texas Ethics Commission Regulations regarding the filing (on line) of a Certificate of Interested Parties (Form 1295). This is a requirement of the state statute §2252.908 of the Government Code and the County may not enter into a contract with a bidder until the Form 1295 is correctly filed with the Texas Ethics Commission. 
