
Notice of Regular Meeting

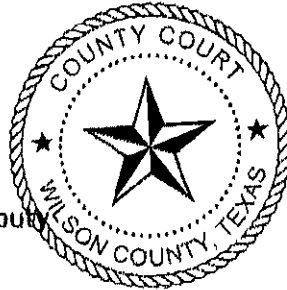

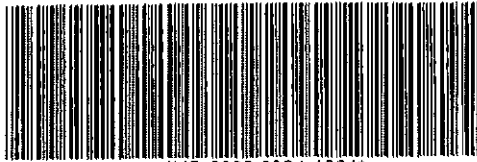
