Having carefully examined the competitive proposal documents, plans, specifications, addenda and thereto, as prepared by PBK Architects, as well as the premises and all the conditions affecting the work, the undersigned proposes to furnish all labor, materials and equipment necessary to complete the entire work in accordance with the Contract Documents.

- This is not a unit price contract. Each contractor is responsible for their own quantities. Contracts will be awarded on a lump sum basis.
- Unit prices per specification 01 22 00 are not a prerequisite of award and are only applicable during the duration of work for changes associated with modified contract drawings.

Required Qualifications: All subcontractors must be able to perform a complete scope of work for their respective trade and must meet any minimum qualification requirements that may be mentioned in these Proposal Documents. Please carefully read all the specifications for this project.

Bonding/Insurance Requirements: SpawGlass requires all subcontractors with a subcontract dollar amount greater than \$250,000 to obtain both a Payment and Performance Bond, in an amount not less than 100% of the Subcontract sum.

SpawGlass requires subcontractors to obtain the following insurance coverage: Worker's Compensation and Automobile Liability at a \$1,000,000 policy; Commercial General Liability with a \$1,000,000 each occurrence / \$2,000,000 general aggregate policy and Umbrella/Excess Liability policy at \$2,000,000 with additional insured and waiver of subrogation endorsements.

Furthermore, by submitting this proposal I understand SpawGlass Construction Corporation's intention to practice <u>Lean Construction</u> <u>Scheduling Techniques</u> (Pull Planning, Constraint Log, Weekly Work Plans, and Daily Huddles) and commit to participate in all part of the process on this project.

Finally, the respondent understands the award of each subcontract or purchase order will be based on the proposal which is deemed the best value to SpawGlass Contractors and the project. SpawGlass Contractors is not bound to accept the lowest priced proposal if that proposal is not in the best interest of SpawGlass Contractors, Wilson County and the project, as determined by SpawGlass Contractors. By submitting a proposal, the respondent acknowledges and accepts that the determination of the best value will require subjective judgments by the construction manager and the Owner. Excluded Parties: Off-site fabricators, vendors, suppliers (who do not perform or subcontract installation), material dealers, demolition, blasting, truckers (including trucking to the Project where delivery is the only scope of Work to be performed), asbestos abatement or other hazardous waste removal Contractor(s) and their respective Subcontractor(s) of any tier, and others whose sole function is to transport, pickup, deliver or carry materials, supplies, tools equipment, parts or other items to or from the project site, or who do not perform any actual on-site labor, any other entity specifically determined by SpawGlass to be excluded will not be covered by insurance purchased by SpawGlass Contractors, Inc. through the CCIP.

Enrolled parties must provide their own insurance for off-site activities including but not limited to work at their permanent shops, fabrication or manufacturing of building products, materials or supplies and travel to and from the project.
